While the virus (SARS-CoV2) that causes COVID-19 remains in wide circulation and the general public remains susceptible, the mitigation measures of social (physical) distancing, use of facial coverings/masks, hand hygiene and cough etiquette, quarantine of exposed individuals, and isolation of those with symptoms or illness provide the only protection to students and staff. The more individuals a student or staff member interacts with, and the longer that interaction, the higher the risk of COVID-19 spread.

Schools, working together with local health departments, have an important role in slowing the spread of diseases and protecting vulnerable students and staff. The goal is to return to more traditional forms of teaching and learning, provide educational and related services, while preventing or minimizing further or future school closures due to COVID-19 or other communicable diseases.

Ms. Wilson will describe the recommendations provide to schools by the Wisconsin Department of Public Instruction in conjunction with the Department of Health Services.

The American Academy of Pediatrics issued guidance to support education, public health, local leadership, and pediatricians collaborating with schools in creating policies for school re-entry that foster the overall health of children, adolescents, staff, and communities, based on available evidence. Schools are fundamental to child and adolescent development and well-being and provide children and adolescents with academic instruction, social and emotional skills, safety, reliable nutrition, physical/speech and mental health therapy, and opportunities for physical activity, among other benefits. Beyond supporting the educational development of children and adolescents, schools play a critical role in addressing racial and social inequity. As such, it is critical to reflect on the differential impact SARS-CoV-2 and the associated school closures have had on different races, ethnic and vulnerable populations. These AAP recommendations are provided acknowledging that the understanding of the SARS-CoV-2 pandemic is changing rapidly.
